In addition, the undersigned declares that the Association it represents:

1. Undertakes to report to the ANH, under its exclusive responsibility, in advance and in writing, any change registered in the address, telephones and email, as the Agency uses those indicated in this Letter for all purposes related to communications and notices.
2. The Forms attached were completed with accurate, true and faithful data, and their supporting documents correspond to reality and were obtained in accordance with the instructions given in their text, in the pertinent instructions, and in the Terms of Reference, without having introduced changes or adjustments, nor altering the order of the information requested.
3. It is aware that the ANH reserves the right to verify the information provided and to carry out checks on the documents supplied, be it before or after the Qualification, Award, and even the execution of the respective Contract or Contracts.
4. The Operator has and will maintain at least a thirty per cent (30%) share in the Association, will undertake the Exploration, Evaluation and Production activities, the leadership and representation of the Association, and will lead the contractual performance and the relationship with the ANH.
5. The Operator and those who have accredited the Financial Economic Capacity shall abstain from assigning or transferring all or part of the proposed Contracts, nor their respective share and interest therein, without prior, express authorization in writing from the ANH. In any event, the assignee must at least meet the Capacity requirements of the assignor.
6. It accepts and undertakes that any eventual assignment of the Operator or another member of the Plural Contractor, are limited to its maintaining at least a thirty percent (30%) share





and upholding the conditions that determine the Qualification, award and execution of the Contract(s).

7. It undertakes to report to the ANH, within thirty (30) Calendar Days following its perfecting, any corporate transaction that implies a change of Real Beneficiary or Operator Holding and/or of those who accredit the Capacity requisites on which basis the Qualification is obtained and the eventual award of the Contract or Contracts, and to supply the supports to determine that the Capacity requisites are upheld. The same rules apply to mergers, equity integration operations or splits of the Operator or any other member of the association, which have accredited said Capacity requisites.
